# VILLAGE OF MERRILLAN

The Village of Merrillan Board of Trustees welcomes you to our nice Village. We are providing you with some key information that should help make your transition easier.



The Village Board meets the First and Second Tuesdays of each month at 7 p.m. and you are encouraged to attend.



**Garbage Pick-up:** Advanced Disposal is the garbage collection provider. Garbage pickup day is Thursdays. If there is a Holiday during the work week then garbage will be picked up the next day on Friday. Any questions on what Advanced Disposal will and will not take you can call them at the following toll free number: 1-888-271-7176. The Village has a Public Nuisance Ordinance that addresses unsightly accumulations of materials and junk and is strictly enforced.

**Please do not place these items at curbside more than 24 before the actual scheduled pick-up day.**



**Leaves/Brush Pick-up Day:** First Monday of every month: Limbs/sticks must be cut in manageable lengths and bundled and or tied or it will not be picked up. Items are to be set out at the road.



**Recycling Pick-up days is done Every Tuesday:** Recyclables will not be picked up if it is raining considerably, the recyclables will instead be picked up the **next non-rain day**. All items should be placed out at the curb by 7 am on the pickup days. Please do not place any items curbside more that 24 hours before the actual scheduled pick-up day.



The Village of Merrillan has a license and leash law and requires all pets to be licensed and under the control of the owner when off your premises. This includes cats. Aggressive animals are not allowed in the Village. Proof of current rabies vaccination from the Vet is required to obtain a pet license.



The Village has several parks available for your pleasure and you can reserve a structure for reunions etc., for a small fee, to be paid at the village hall minimum two weeks prior to the event in order to hold your reservation and it is on a first come first served basis.



Please contact the Village Zoning Administrator or UDC Building Inspector (below) to determine if a Building or Zoning permit is required before beginning any building, fencing, remodeling or additions to your property or stop in at the Village Hall.
